



“Meeting of the Professionals” Annual Training Review

On December 9, 2009, the North Carolina Substance Abuse Professional Practice Board hosted Licensed Clinical Addiction Specialists and Certified Substance Abuse Counselors at its first annual training event held at Wake Tech Community College’s West Campus in Cary. The training consisted of two tracks from which attendees could choose to attend: *Clinical Supervision and Ethical Practice* presented by Board member L. Worth Bolton, LCAS, CCS and *Effective Groupwork for Addiction Counselors* presented by Board member Jessica

Holton, LCAS. Board staff was present to answer credentialing questions as well as provide refreshments and coffee during breaks.

Due to inclement weather, a number of participants were not able to attend. Among the eighty counselors who did attend the training, there was great excitement about the opportunity to earn training credit free of charge and learn something new about their field from NCSAPPB Board members.

The response from counselors following the training event was overwhelming. Post-training evaluations

were distributed and collected. Among the recommendations made were suggestions that a greater variety and number of tracks be offered in the future, that the training occur over a period of several days instead of a consolidated, one-day event and that all credentialed counselors be invited to attend the event.

The Board staff appreciates the feedback that was received and will endeavor to take these recommendations into consideration when planning 2010’s event. Thank you for your feedback and continued support of the Board!
