The Board also voted to seat **Mark Crabtree**, LCAS and CCS, in the Board-appointed seat vacated by Lynn Inman.

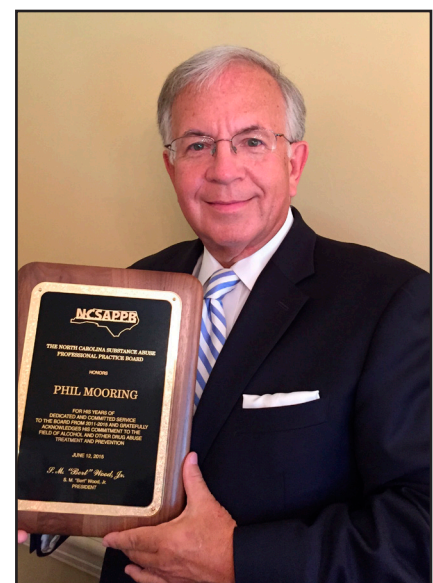
The Board is a mixture of elected and appointed seats. The NC Department of Health and Human

Thoughts On Ethical Boundaries in the Supervisory Relationship

When I think about the ethical boundaries in the supervisory relationship two questions come to mind. “What are the ethical obligations of a supervisor and supervisee towards each other?” and “How is the supervisory relationship similar to the counseling relationship?”

In attempting to answer those questions I went to one of my favorite resources, David Powell’s book *Clinical Supervision in Alcohol and Drug Abuse Counseling*. In that book David described the supervisory relationship as being like the therapeutic relationship in that both involve inherent inequalities of status, power, and expertise. Both involve self-evaluation in conjunction with assessment by an authoritative figure, personal growth, and the supervisor’s carrying a role in this process. The nature of supervision, therefore, has the potential for abuse and impropriety just as in counseling. David also described supervision as a training experience where the supervisee learns the practice of counseling which includes the rules of therapy and the behavioral mandates around ethical principles.

A valuable lesson I learned in training with David that nearly terrified me out of being a supervisor was the principle of “vicarious liability” which means the supervisor can be held liable for the actions of the supervisee.

This led me to contemplate how the supervisory relationship is

similar to the counseling relationship as described above and also to contemplate how one inherent difference is that the supervisee has a greater obligation to the supervisor than a client would have to a counselor. Actually, we might say that a client owes no particular ethical obligation to the counselor. In the client/counselor relationship it is the counselor’s responsibility to adhere to healthy ethical boundaries. A supervisee, however, is also a professional bound by the same code of ethics as the supervisor. So, while the supervisor has the greater level of experience and power in the supervisor/supervisee relationship the supervisee still has an obligation to adhere to healthy ethical boundaries.

Many of the same ethical considerations would apply to the supervisory relationship as to the counselor relationship. Some would be those related to dual relationships, informed consent, confidentiality, sexual involvement, and not practicing outside areas of expertise.

I would encourage readers, both supervisors and supervisees, to read the section on ethical considerations in David’s book. He did a much better job of exploring the topic than I can ever hope to do.

Tips and Tricks using LearningBuilder

Using our online credentialing system can help you manage your Learning Plan and renewal. Here are some tips for using the site.

- The term “application” is interchangeable with “Learning Plan.” Applications for a credential and to renew a credential are found under the link “Learning Plans.”
- The procedure for applying for a credential is still done in steps. Your *Learning Plan* will only unlock certain capabilities once requirements are met. For example, you cannot enter the email address of a reference letter until you have reached Intern or Associate Status.
- Think of your *Learning Plan* as your online storage for your training certificates. Don’t wait to start working on your renewal. You will always have a renewal *Learning Plan* open for you to upload a recently completed training.
- Know the difference between “Upload” and “Download.” Upload means to take something from your computer or flash drive and put it in your *Learning Plan*. Download means to take something from your *Learning Plan* and store it on your computer or flash drive for later use or editing.
- Is your supervisor not getting the email request to confirm supervision? Check the email address you have entered. You may have entered it incorrectly!
- Uploading trainings and don’t have an approval code? Mark it “N/A” and keep going. Board staff will review it and let you know if there is additional information needed.
- If you have a stack of certificates, scan them all into one PDF document. You only have to do one upload then (when you enter the first course). For all the other courses, enter the information and click “Library.” Your previous uploads are there ready to be referenced again!
- Make sure your name is listed how you want it to be printed on official documents. This includes capitalization! Email the board office if you need to make changes.
- Clicking the “?” next to each heading in your Learning Plan will give you instructions on what is required there.
