THIS CAUSE came on to be heard before the North Carolina Addictions Specialist Professional Practice Board ("the Board") on July 23, 2021, on the Second Notice Of Hearing dated April 26, 2021. Johnny Bass, Treasurer of the Board, presided.

The Board, having received the evidence and having heard the arguments of counsel, makes the following FINDINGS OF FACT:

- 1. Petitioner North Carolina Addictions Specialist Professional Practice Board ("the Board"), was established by G.S. 90-113.32, and is recognized as the registering, certifying, and licensing authority for substance abuse professionals described in the Practice Act. The Board was established to safeguard the public health, safety, and welfare, to protect the public from being harmed by unqualified persons, to assure the highest degree of professional care and conduct on the part of credentialed substance abuse professionals, to provide for the establishment of standards for the education of credentialed substance abuse professionals of high quality to persons in need of these services. The Board, under authority granted by the Practice Act regulates Board-credentialed persons offering substance abuse counseling services, substance abuse prevention services, or any other substance abuse services for which the Board may grant registration, certification or licensure.
- During all relevant times, Respondent Andrew McDonald was a Certified Alcohol and Drug Counselor - Intern (CADC-I No. 22338). Respondent's status as an CADC-I expired on January 19, 2021.
- On December 11, 2020, the Board received an Ethics Complaint ("the Complaint")
 against Respondent.
- On December 14, 2020, Michael McGuire, Ethics Committee Chairman, sent a copy of the Complaint to Respondent, demanding response, within thirty (30) calendar days of receipt, to the allegations contained therein.

- 5. On January 19, 2021, the Board having received no response to the Ethics Complaint, counsel for the Board send a letter to Respondent, demanding that Respondent respond to the Complaint by February 19, 2021, and noting that failure to respond constituted a failure to cooperate with the Board's investigation, in violation of 21 NCAC 68 .0510, and grounds for discipline under 21 NCAC 68 .0601(7)(e). The Overnight Envelope containing the letter was signed for on January 20, 2021.
- On April 26, 2021, the Board issued a Second Notice Of Hearing, which was served on Respondent on April 29, 2021.
- Respondent has made no response to the Complaint; and did not appear at the timely noticed hearing.

BASED UPON THE FOREGOING FINDINGS OF FACT, THE COURT CONCLUDES AS A MATTER OF LAW:

- Respondent is subject to the North Carolina Addictions Specialist Professional Practice Act and the rules promulgated thereunder. The Board has jurisdiction over the person of the Respondent and the subject matter of this proceeding.
- Pursuant to 21 NCAC 68. 0601 and other provisions of the 21 NCAC 68.0101 et seq., grounds exist to discipline Respondent relating to the facts and circumstances set forth above, and particularly for failure to cooperate with the Board's investigation of the Complaint, up to and including permanent revocation of Respondent's status as a CADC.
- The appropriate discipline to impose, with respect to the actions alleged above, is permanent revocation of Respondent's status as a CADC-I.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

- 1. Respondent's status as CADC-I, No. 22338, is permanently revoked.
- Each party shall bear their own costs.
